1. Overview

Curt Creation and its subsidiaries (collectively, "Curt Creation" or "we" or "our") respect your privacy. This privacy policy (this "Policy") informs you of our privacy practices and the choices you can make about the way your information is collected online and how that information is used.

This Policy applies to all websites, servers and services owned or provided by Curt Creation (collectively, "Curt Creation Sites"). Curt Creation may add new sites, domain names or services from time to time. As explained below, this Policy applies only to websites owned and services maintained by Curt Creation and not to websites or services to which links may be provided on Curt Creation Sites.

BY USING THIS SITE, OR ANY PRODUCT OR SERVICE OFFERED ON THIS SITE, YOU CONSENT TO THE COLLECTION, USE AND DISCLOSURE OF INFORMATION AS DESCRIBED IN THIS POLICY.

Collection of Personal Information Curt Creation collects personal information from users of Curt Creation Sites in connection with the access and use of the various products and services available to you on Curt Creation Sites. These products and services may include: (i) registration as a Curt Creation user and/or subscribing to Curt Creation Services; (ii) use of the Curt CreationX Client; (iii) registration for competitions and events; (iv) registration for receipt of communications like email updates and newsletters; (v) registration for certain online community services and tools like message boards, chat rooms, forums, news groups or other community services; (vi) user surveys and polls; (vii) participation in sweepstakes, contests or promotions by sponsored by Curt Creation or third parties; and (viii) purchasing products and services.

A. Types of Information Collected. Curt Creation collects information you provide to us. This may include your name, address, ZIP code, telephone number, email address, user IDs and passwords, age and date of birth, gender, billing and transaction information, product and service preferences and contact preferences. In certain instances, you may also submit similar information about other people (such as when shipping products purchased on Curt Creation Sites).

- B. Automatic Data Collection. In addition to the information you provide us, Curt Creation may also automatically collect information regarding your use of Curt Creation Sites. Our automatic data collection may include:
- 1. Cookies, web beacons or other commonly used website analytics tools. These tools collect certain standard information that your browser sends to our website such as your browser type and language and access times. These tools may also collect information about your Internet Protocol (IP) address, clickstream behavior (i.e., the pages you view, the links you click and other actions you take in connection with Curt Creation Sites) and products and services you use.

- 2. Pixel tags, web beacons or other commonly used email analytics tools. These tools may collect information when you open an email or click a link contained in an email or on Curt Creation Sites.
- A. Commingled Information. Curt Creation may also collect information from commercially available sources that it deems credible. Such information may include your name, address, email address and demographic data. The information Curt Creation collects from its commercial sources may be used along with the information Curt Creation collects when you visit Curt Creation Sites. For example, Curt Creation may compare the geographic information acquired from commercial sources with your IP address to derive your general geographic area.
- B. Community Tools. From time to time, Curt Creation may make message boards, chat rooms, forums, news groups and other community tools available to you on Curt Creation Sites. Please keep in mind that whenever you voluntarily disclose personal information in these public areas, your information becomes public information and can be viewed and used by Curt Creation and others.
- C. Purpose for data collection. Data is collected for business requirements including the provisioning of Curt Creation services and its functions and contents, answering contact requests and communicating with users, security measures, and audience measurement and marketing.
- 2. How We Use Your Personal Information

We use the personal information you provide to us (i) in the manner described in this Policy, (ii) to improve and customize this site and the products and services offered to you, and (iii) as directed by you as indicated by your use of the products and services offered on this site. For example, we may use your personal information in connection with the following:

- A. Creation of membership accounts;
- B. Enforce bans;
- C. Offers to participate in competitions and event;
- D. Delivery of email updates and newsletters;
- E. Communications of offers for promotions, sweepstakes and contests;
- F. Invitations to participate in user surveys and polls;
- G. Execution of purchases of products and services; and
- H. Providing software updates and interactive materials.

We may also use your personal information to contact you offline concerning the products and services offered on this site. You are able to opt out of communication at any time by using the "unsubscribe" feature within the communication you receive, or by revoking consent to our services.

3. Sharing of Personal Information

Curt Creation will not sell, rent or lease the personal information you provide. Curt Creation will only share your personal information:

- A. With entities owned or controlled by Curt Creation;
- B. With your consent;
- C. With persons or entities engaged by Curt Creation to carry out or fulfill Curt Creation operations;
- D. In connection with a merger, acquisition, reorganzization or sale of assets by Curt Creation; E. As required by a duly authorized request from a government authority, to comply with any law, regulation, warrant, subpoena or order from a court or governmental authority, and to help prevent or investigate suspected fraud, harassment or violation of any law, rule, regulation, Curt Creation policy or Curt Creation terms and conditions; and
- F. As otherwise stated in this Policy.

4. Use and Disclosure of Anonymous Information

We may collect certain non-personally identifiable information (i.e., generic information that does not identify you personally) when you visit any Curt Creation Site. We may use non-personally identifiable information that we collect to improve the design and content of Curt Creation Sites and to enable us to personalize the products and services offered on Curt Creation Sites. We may also aggregate non-personally identifiable information collected in a manner which does not identify any individual. We reserve the right to use this information in any manner we deem appropriate.

5. Children Under 13

Curt Creation Sites are not directed to children under the age of 13. Curt Creation Sites prohibit registration by, and Curt Creation will not knowingly collect personally identifiable information from, anyone under the age of 13. If you believe Curt Creation has collected personal information about your child, you may contact us at the address set forth below to request removal of such information.

6. Links to Third Party Sites

Curt Creation Sites may include links to third party websites or services. Curt Creation does not control such third party sites and their privacy practices are not covered by this policy. The presence of a link on Curt Creation Sites does not constitute an endorsement or representation regarding any third party website or service.

7. Information Storage and Security

The protection of your personal information is important to Curt Creation. To prevent unauthorized access or disclosure of this information, Curt Creation utilizes appropriate physical, technical and administrative procedures to safeguard the information we collect. However, no system can ever be fully protected against every possible hazard and we cannot guarantee that communications between you and us or the information stored on Curt Creation Sites or our servers (or those of our agents and service providers) will be completely free from unauthorized access and disclosure and your use of any Curt Creation Site demonstrates your assumption of this risk.

8. Your Choices

Curt Creation provides you with the opportunity to choose and alter your preferences regarding the communications you receive from us. You will be provided with the opportunity to indicate whether you want to receive general communications about products, services, special offers or invitations to participate in various programs. You may opt out of receiving these general communications by using one of the following methods: (i) select the email "opt out" or "unsubscribe" link, or follow the opt-out instructions included in each communication, or (ii) write to Curt Creation at the address below. Be sure to provide your name, email and postal address, and specific relevant information about your privacy preferences. Subscription communications may include email newsletters and updates expressly requested by you. After you request such communications, you may opt out of receiving them by using one of the following methods: (i) select the email "opt out" or "unsubscribe" link, or follow the opt-out instructions included in each subscription communication, or (ii) return to the Web page(s) where you originally requested such services and follow the opt-out instructions.

You may change or edit information you have provided as part of your user profile by logging in to your Curt Creation account and changing the information. You may export and delete your user profile by logging into your Curt Creation account accessing your privacy settings. You may revoke consent at any time by logging into your Curt Creation account and accessing your privacy settings.

9. International Users

If you are visiting this site from a location outside Singapore, your connection will be through servers located in the Singapore and all information you provide will be processed and maintained in our web servers and internal systems located within Singapore. By using this site, you authorize the export of personal information to Singapore and its storage and use as specified above.

10. Payment Transactions

For a contract, in which you have to pay a fee, provided that the purchase was made via the website, your credit card information will be collected by the payment processor (credit card number, country, holder of the credit card) in accordance with Art. 6 (1) (a) and (f) GDPR credit card, credit card verification code (CVV code) and expiration date of your credit card), your name, bank account number and bank code if you choose the direct debit or if you choose another payment method or if you choose SEPA direct debit, your IBAN (international bank account number) and your BIC (International bank code of the institution of the debtor), and your home address. Please note that your credit card details or PayPal payments are collected and processed by your payment processor in relation to your payments for the service.

11. Social Media

Curt Creation maintains online presence within social networks and platforms in order to communicate with customers and users active there, and to inform them about Curt Creation services. When calling the respective networks and platforms, the terms and conditions and the data processing guidelines apply to their respective operators.

Unless otherwise stated in our Privacy Policy, users' data will be processed as long as they communicate with Curt Creation within social networks and platforms, e.g. write posts on Curt Creation's online presence or send messages.

12. Integration of Services and Contents of Third Parties

Based on Curt Creation's legitimate interests (such as interest in the analysis, optimization and economic operation of our online offer within the meaning of Art. 6 (1) lit. GDPR), Curt Creation make use of content or services offered by third-party providers in order to provide their content and services, such as including videos (hereinafter collectively referred to as "Content").

This always presupposes that the third party providers of this content perceive the IP address of the users, since they could not send the content to their browser without the IP address. The IP address is therefore required for the presentation of this content. Curt Creation endeavors to use only content whose respective providers use the IP address solely for the delivery of the content. Third parties may also use so-called pixel tags (invisible graphics, also referred to as "web beacons") for statistical or marketing purposes. The "pixel tags" can be used to evaluate information such as visitor traffic on the pages of this website. The pseudonymous information may also be stored in cookies on the user's device and may include, but is not limited to, technical information about the browser and operating system, referring web sites, visit time, and other information regarding the use of Curt Creation Sites.

B. Facebook

Curt Creation also use social plugins ("plugins") of the social network facebook.com, which is provided by Facebook Ireland, on the basis of Curt Creation's legitimate interests (analysis, optimization and economical operation of Curt Creation's online offer as defined in Art. 6 (1) lit. GDPR) Ltd., 4 Grand Canal Square, Grand Canal Harbor, Dublin 2, Ireland ("Facebook"). The plugins can represent interaction elements or content (such as videos, graphics or text contributions) and can be recognized by one of the Facebook logos (white "f" on blue tile, the terms "Like", "Like" or a "thumbs up" sign) or are marked with the addition "Facebook Social Plugin". The list and appearance of Facebook Social Plugins can be viewed here: https://developers.facebook.com/docs/plugins/.

Facebook is certified under the Privacy Shield Agreement, which provides a guarantee to comply with European privacy legislation (https://www.privacyshield.gov/participant?id=a2zt0000000GnywAAC&status=Active).

When a user invokes the feature that contains such a plugin, their device establishes a direct connection to the Facebook servers. The content of the plugin is transmitted by Facebook directly to the device of the user and incorporated by him into the online offer. In the process, user profiles can be created from the processed data. Curt Creation has no control over the amount of data Facebook collects using this plugin.

By integrating the plugins, Facebook receives the information that a user has accessed the corresponding page of the online offer. If the user is logged in to Facebook, Facebook can assign the visit to his Facebook account. If users interact with the plugins, for example, press the Like button or leave a comment, the information is transmitted from your device directly to Facebook and stored there. If a user is not a member of Facebook, there is still the possibility that Facebook will find out and save their IP address.

The purpose and scope of the data collection and the further processing and use of the data by Facebook, as well as the related rights and setting options for the protection of your privacy, can be found in the privacy policy of Facebook: https://www.facebook.com/about/privacy/.

If a user is a Facebook member and does not want Facebook to collect data about him via this online offer and link it to his member data stored on Facebook, he must log out of Facebook and delete their cookies before using Curt Creation Sites. Other settings and inconsistencies

The settings are platform independent and they are adopted for all devices, such as desktop computers or mobile devices.

C. Twitter

By clicking on the Twitter button and the "Re-Tweet" function, the websites you visit are linked to your Twitter account and shared with other users. This data is also transmitted to Twitter. Curt Creation points out that as the provider of the Curt Creation Sites, Curt Creation is not aware of the content of the transmitted data and their use by Twitter.
